A C Rule C-5 - No beer shall be sold or served to persons under legal age. A person must be 21 years of age to buy, consume, or possess beer. The burden of ascertaining the correct age of minor customers shall be upon the owner, operator and employees of the business.

AC Rule C-12 - Licensee shall not permit dancing on his premises without proper dance permit issued by the City of Memphis/Permit Office.

A C Rule D- 4 - Proof of legal age is required of all customers beverages are served or sold to such persons.
