Dear Director Armstrong:

We have completed our attestation engagement of Property & Evidence (P&E) regarding the final disposition of confiscated firearms. The firearms were transferred on October 30, 2014. Our primary objectives were to determine if the firearms selected for transfer were properly authorized. A secondary objective was to provide reasonable assurance to interested parties that P&E personnel performed due diligence prior to transferring the items. Lastly, our objective was to provide reasonable assurance that all firearms were actually transferred.

To accomplish our objectives, we agreed information for 100% of the firearms on Court Order P40597 to each specific firearm. We reviewed, on a sample basis, documentation that showed due diligence had been performed prior to transferring the items. Lastly, we observed the storage, control and final transfer of the firearms to the Tennessee Bureau of Investigation.


Based on our procedures, firearms selected for transfer were properly authorized and transferred. We noted no discrepancies and no further action is needed.

We conducted this attestation engagement in accordance with generally accepted government auditing standards. Those standards require that we plan and perform the engagement to obtain sufficient, appropriate evidence to provide a reasonable basis for our findings and conclusions. We believe that the evidence obtained provides a reasonable basis for our findings and conclusions based on our audit objectives. Our engagement may not necessarily disclose all weaknesses related to the disposition process.


