WHO QUALIFIES?

- Age 65 or Older
- Fixed income (SSI, SSA, Pension, etc.)
- Own and live in the home that is your primary residence
- Taxes must be paid on prior years
- No minimum or maximum income requirements

HOW DO I APPLY?

Quarterly Affidavit must be submitted by August 31, 2023 Quarterly payments are due August 31, 2023 - November 30, 2023 February 28, 2024 and May 31, 2024

WHO QUALIFIES **FOR TAX RELIEF** AND/OR **TAX FREEZE PROGRAM?**



You must be a resident of the city and meet one or more of the following guidelines below.

If your residence is a mobile home, a copy of your title or bill of sale is required. You must own and use the property as your primary residence.

Elderly: Age 65 or will be 65 before December 31, 2023. Your combine income for you, your spouse, and all other owners of the property cannot exceed \$33,460.

DISABLED

If you are a disabled homeowner, you must have been rated totally and permanently disabled by Social Security Administration or other qualified agencies and your total income cannot exceed \$33,460.

No income limit for Disabled Veterans who are:

- Totally & permanently disabled
- Widow(er) of a disabled veteran
- Widow(er) of a soldier killed in action

TAX FREE ELIGIBILITY

- Must be 65 or older before December 31. 2023.
- Must provide proof of age (Birth Certificate, Drivers License, State ID, etc.).
- You must own and use the property as your primary residence.
- Must provide proof of income of spouse whether living on the property or not.
- Must provide proof of income for all owners of the property.
- The combined income for you, your spouse, and all other owners of the property must not exceed \$43,980.

- Social Security benefits Statement (after Medicare is deducted)
- Supplemental Security Income (SSI)
- Retirement or Pension Benefits
- Veteran's Administration Benefits
- Workers' Compensation
- **Unemployment Benefits**
- Salaries or Wages
- Interests and Dividends
- Income Tax Returns
- Alimony
- Annuity

All programs require applications every year. Law requires the income of the applicant's spouse to be included, regardless of ownership.
