- B5: Beer permits are not transferable from person(s) or location(s). Any new owner of a business must have a beer permit issued in his/her own name.
  - C5: No beer shall be sold or served to such persons under legal age. A person must be 21 years of age to buy, consume or possess beer. The burden of ascertaining the correct age of minor customers shall be upon the owner, operator and employees of the business.
  - D4: Proof of legal age is required of all customers before any alcoholic beverages are served or sold to such persons.
